Description and Purpose of Change:

MaxLinear discontinues the above listed devices.

The process technology has been discontinued by the silicon foundry and will be ramped down in early 2022.

Orders placed with Maxlinear are Non-Cancelable and Non-Returnable

Maxlinear has engaged Supply Partner Rochester Electronics to enable extension of shipments through 2033

Maxlinear will take LTB orders with LTS extended through 2024. These orders will be NCNR

Maxlinear will take customer forecast and collect a 20% non-refundable NRE for orders shippable starting 2025 and through 2033. NRE purchase order will be due on 05/01/2022.

Maxlinear will maintain a 'Customer Commitment List' which will include customers who provided forecast for 2025-2033 and paid the non-refundable NRE.

Pricing for shipments in 2025 will have a price increase of 20% and an annual price increase of 3% starting 2026 and through 2033.

Supply Partner will accept LTB orders from customers based on MXL's 'Customer Commitment List'

Supply Partner will take over the ownership for manufacturing, shipment, and support of parts starting 2025 and through 2033.

Parts will be sold under Supply Partner's brand and part numbers and their terms and conditions of sale.
